EDITORIAL REQUIREMENTS

ATTENTION!

The editor reserves the right to reject papers which do not meet editorial requirements without further review. Submitted papers will be subject to a double-blind review process.

GENERAL PROVISIONS

- Word text editor (doc. or docx. format).
- Font style Times New Roman.
- Font size of the main text -12 pt.
- Font size of footnotes 10 pt.
- Line spacing (main text) -1.5 pt.
- Line spacing (footnote) -1.0 pt.
- Standard A4 page (30 verses of 60 characters each).
- Text alignment: justified.
- Standard margins, all 2,5 cm each.
- Paragraph notch: single tabulation, i.e. 1.25 cm.
- In the "Paragraph" function, spacing before and after shall be set to 0 pt.
- To distinguish the text in foreign languages use only *italics* (e.g. English, German, Latin), whereas the **bold text** is used only for phrases in Polish.
- Do not use <u>underscores</u> or shot-and-shot print.
- Titles of books are given in *italics*, titles of magazines in "quotation marks".
- The quoted fragments of texts and legal acts shall be marked with "quotation marks".
- Enumeration shall be made by means of the following sign -
- Names appearing in the main text should be given with the initials of the first name.
- Digital footnote reference shall be placed immediately after the part to which the footnote refers (before the dot ending the sentence).
- Title shall be written in Times New Roman 14 pt. font, **bold** and justified.
- Subtitles shall be in Times New Roman font, 12 pt., **bold**, aligned to the left.
- Subtitles shall not be numbered.

- Subtitles shall be separated from the main text by a single line from the top and bottom.
- Do not use hard spaces or automatic word splitting.
- Minimum volume of the paper is 20,000 characters and maximum 25,000 characters (including characters with spaces, text fields, footnotes and footnotes.
- Maximum volume of a paper may be 20,000 characters. This number includes characters with spaces, text fields, footnotes).
- Authors shall attach the following information to the text: degree or title, name, surname, affiliation (department, faculty, university). The information shall be placed in the top left corner of the title page in *italics*.
- Paper shall be accompanied by a summary in Polish and English (up to 1000 characters), key words in Polish and English (about 5-10) and a translation of the title of the paper in English. They shall be placed after the main text and before the bibliography.
- It is required to prepare an bibliography. It should be placed at the end of the paper.
- Photographs included in the text shall be submitted in separate files in JPG format.

TABLES AND DRAWINGS

- Descriptions of tables and drawings (photos, diagrams, maps, etc.) shall be placed directly above and below them (without line spacing).
- Tables (Tab.), figures (Fig.), photographs (Photo) shall be numbered separately.
- Headers of tables and drawings shall be left aligned and in font style: Times New Roman, 11 pt.
- Source shall be left aligned and written in Times New Roman font, 11 pt, in *italics*.
- Text in the tables shall be written in Times New Roman font, 10 pt., in *italics*.

Fish poaching in the light of Inland Fishing Act

The roots of fishing and angling go back to the beginnings of mankind. The first fishing gear found in the Euphrates Valley dates back to 3,000 BC¹. Lines, hooks and artificial flies were also used in ancient Egypt, Greece, Rome and China². The first angling textbooks include J. Berners' "Treaty on angling" from 1496, W. Samuel's "Art of Fishing" from 1577 and I. Walton's "Perfect Fisherman" from 1653, which has been the subject of 400 editions³.

History of fishing in Poland

Fishing appeared on Polish lands in the early Middle Ages. Archaeologists, mainly in Pomerania, Masuria, Kujawy and Wielkopolska, find tin, lead and silver spinners from this period⁴. Fish were an important source of food in the Polish state, and their importance increased after the introduction of Christianity (fasting). In the feudal state, the legal institution connected with fishing was the fishing exclusivity of the ruler (*ius regale*)⁵. The first act in independent Poland, which regulated the conditions of fishing and angling was the Act on Fisheries in Inland Waters, passed on March 7, 1932⁶.
